INTERNET USAGE PERMISSION FORM

Dear Parent or Guardian:

Technology is becoming an integral part of today's curriculum. With the use of technology our students have access to the world. This is not something we take lightly. It is the responsibility of the school to make sure that the internet is used safely and only for the purpose of education. It is only with your permission that your child will be able to access the internet at school as part of their class instruction. Below are the rules for use at our school. Please read before you consider granting permission and review the rules with your child.

GUIDELINES FOR INTERNET USE

1. All students must have a signed permission slip from their parents/guardian that authorizes them access to the Internet.
2. Respect for the equipment of the school and its network is a condition for use of the computers.
3. The student in whose name an on-line services account is issued is responsible for its proper use at all times. User shall keep personal account numbers, home addresses, and telephone numbers private. They shall use the system only under their own account logon.
4. The school's system shall be used only for purposes related to education. Commercial, political, and/or personal use unrelated to an educational purpose is strictly prohibited.
5. The school reserves the right to monitor any on-line communications for improper use. Electronic communications and downloaded material, including files deleted from a user's account, may be monitored or read by school officials.
6. The use of the school's system is a privilege, not a right, and inappropriate use shall result in the cancellation of those privileges.
7. Students are prohibited from accessing, posting, submitting, publishing, or displaying harmful matter or material that is threatening, obscene, disruptive or sexually explicit, or that could be construed as harassment or disparagement of others based on their race, national origin, sex, age, disability, religion or political beliefs.
8. Copyrighted material may not be placed on the system without the author's permission.
9. Students must gain clearance from the teacher before downloading any program from the Internet.
10. Users shall not read other users' files nor shall they attempt to delete, copy, modify or forge other users' files.
11. Users shall report any security problem or misuse of the Internet to the teacher or Administrator. Deliberate attempts to degrade or disrupt system performance will result in disciplinary action.
12. Both student and parent or guardian must sign this permission slip before a student will be allowed to use the Internet.
13. Students who fail to abide by the school's rules shall be subject to disciplinary action, revocation of the user account and legal action as appropriate.
